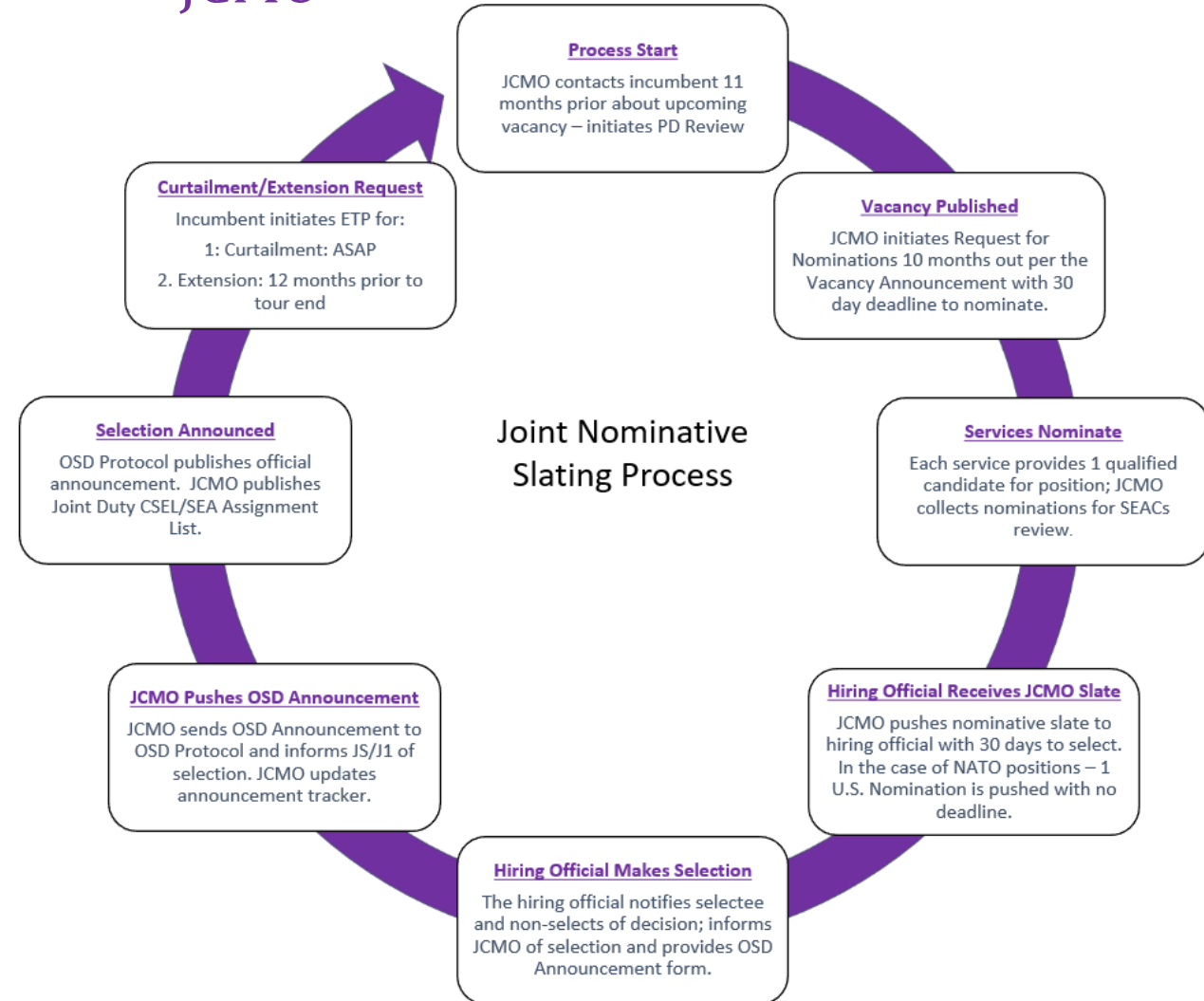
- PROVIDES PROCEDURAL GUIDANCE FOR THE SERVICES AND THE NATIONAL GUARD BUREAU, COMBATANT COMMANDERS, DEPARTMENT OF DEFENSE AGENCIES AND INTERNATIONAL ORGANIZATIONS TO FOLLOW.
- OUTLINES THE FRAMEWORK FOR THE NOMINATIVE PROCESS, APPLYING FOR TOUR WAIVERS/CURTAILMENTS, AND INCLUDES ELIGIBILITY REQUIREMENTS.
- INSTITUTES A FAIR, TRANSPARENT, AND EQUALLY COMPETITIVE JOINT SENIOR ENLISTED TALENT MANAGEMENT PRACTICE.

## NATO & ALLIED PARTNERSHIPS



### INTERNATIONAL OR MULTINATIONAL ASSIGNMENTS

- THE SUPREME ALLIED COMMANDER OR FOREIGN NATIONAL COMMANDER REQUESTS A UNITED STATES NOMINEE
- THE JCMO COORDINATES WITH THE DESIGNATED LIAISON FOR TIMELINE AND REQUIREMENTS
- THE JCMO PUSHES THE REQUEST FOR NOMINATIONS TO THE SERVICES
- THE SERVICES SUBMIT NOMINATIONS
- SEAC, IN CONJUNCTION WITH THE SERVICE SEAs, SELECTS FINAL UNITED STATES NOMINATION — ONLY ONE NOMINATION IS SUBMITTED
- IF THE U.S. NOMINEE IS SELECTED, THE LIAISON NOTIFIES THE JCMO.
- JCMO PUSHES A FORMAL DOD-WIDE ANNOUNCEMENT

# OFFICE OF THE SENIOR ENLISTED ADVISOR TO THE CJCS JCMO

## ELIGIBILITY



- ✓ MEET RETENTION REQUIREMENT
- ✓ MEET SECURITY CLEARANCE REQUIREMENT
- ✓ MUST BE ELIGIBLE FOR TITLE 10 (NGB ONLY)
- ✓ MUST BE ABLE TO COMPLETE PRESCRIBED TOUR LENGTH IN ACCORDANCE WITH THEIR SERVICE'S RETENTION CONTROL PIONT/HIGH-YEAR TENURE
- ✓ MUST NOT BE CURRENTLY FLAGGED, UNDER INVESTIGATION, OR PENDING CHARGES FOR A UNIFORM CODE OF MILITARY JUSTICE OR CIVIL VIOLATION
- ✓ MUST BE FAVORABLY ENDORSED BY THEIR RESPECTIVE SERVICE SEA
- ✓ MUST NOT BE APPROVED TO BE RELEASED OR SEPARATED FROM MILITARY SERVICE BY A TOUR CONTINUATION OR RETENTION BOARD
- ✓ MUST NOT BE WITHIN 3 YEARS OF REACHING THE MAXIMUM AGE AND ALLOWED TO SERVCE WITHOUT AN APPROVED WAIVER
