

## Ray, Charles (Charlie)

ADM, USCG (Ret)

Charlie Ray served four decades as a tactical, operational, and strategic leader in Coast Guard mission sets around the globe. He also served in the joint environment both domestically and in combat zones and as the Head of Delegation for multiple international engagements. He is recognized and trusted across the U.S. interagency as a reliable partner and leader in crisis management.

Admiral Ray retired in 2021 after serving as the 31rst Vice Commandant of the Coast Guard. As Vice, he served as the Deputy Service Chief, and Senior Acquisition Official during a period when the Service initiated and sustained the most growth in ship building and infrastructure recapitalization since WWII. He also was responsible for developing policies and procedures to support sustained Coast Guard Search and Rescue, Law Enforcement and Security operations during the Pandemic and for supporting multiple DHS surge missions in the heartland and on the Southern Border.

Prior to Service as Vice Commandant, he served as Deputy Commandant for Operations, where he set operational strategy and policy that addressed national and Service priorities for Coast Guard: intelligence; international affairs; cyber; the maritime transportation system; search and rescue; maritime security; law enforcement; defense operations; environmental response and contingency planning. He was also responsible for developing requirements for future: cutter, boat, aviation, shore, cyber, and deployable specialized forces. Leading the Coast Guard's maritime regulatory and inspection functions, he regularly partnered with industry groups to address threats to maritime commerce.

Admiral Ray commanded in the Pacific Area with operational responsibility for all Coast Guard forces from Antarctica to the Arctic and from the Rocky Mountains to the East Coast of Africa. He was the Head of Delegation for multiple international engagements in the North Pacific and Arctic Coast Guard Forums that included frequent interaction with representatives from the Coast Guards of the Peoples Republic of China and Russia. He was also regularly engaged in bilateral coordination with allies and partners across the Pacific and Oceania in coordinating operations addressing illegal fisheries, search and rescue and security operations. Admiral Ray was a driving force in increasing awareness of the strategic significance of the Arctic and in testifying on the resource requirements to execute Coast Guard missions in the Polar Regions.

From a joint military perspective, he was the Director of the Iraq Training and Mission to the Ministry of Interior with U.S. Forces Iraq from 2009 to 2010. In this assignment he led a joint team of advisors from all military services and multiple police specialties in direct support to the Ministry of Interior in all aspects of manning, training, and equipping Police Security Forces in Iraq. Domestically, he served as the Military Advisor to the Secretary of Homeland Security during a period involving significant increases in Defense Support for Civil Authorities.

Admiral Ray spent most of his operational time as an aviator and earned aircraft commander and instructor pilot ratings in multiple helicopter types. He served as detachment commander for shipboard deployments from the Bering Sea to the Caribbean and Commanded the Coast Guard Air Station in Puerto Rico. Charlie flew over 5000 helicopter flight hours and was the longest serving aviator in the Coast Guard in his final 4 years of Service thereby earning the title of "Ancient Albatross".

He holds a Bachelor of Science Degree from the Coast Guard Academy, a Master of Science Degree from The Industrial College of the Armed Forces and a Master of Science in Industrial Administration from Purdue University. He holds FAA certifications in both helicopters and fixed wing aircraft.

Admiral Ray currently serves as the Dr. James S. Tyler Chair in Leadership Development at the Loy Institute for Leadership at the U.S. Coast Guard Academy.



Command Chief Master Sergeant (Retired) Gregory A Smith is the Chief Executive Officer of TIGRE Global Solutions Inc. TIGRE Global Solutions Inc focuses on emerging technology, discreet capabilities, and developmental systems that advance National Security.

Greg started his military career with the United States Air Force in 1990 as an aircraft armament systems specialist. He was selected for special duty as an AC-130H/U Aerial Gunner in 1996. He served as Lead, Instructor, and Evaluator Gunner with the 4th Special Operations Squadron, Hurlburt Field, Florida.

Greg was part of the first team to deploy following the terror attacks on 9/11. He established the first forward operating base and then deployed to Pakistan where he established a joint interagency forward operating location. In 2009, Greg became the first course director and chief of academics for the Joint Special Operations Forces Senior Enlisted Academy (JSOFSEA).

In January 2012, Greg was selected for Command Chief Master Sergeant for the 58th Special Operations Wing where he oversaw the training and readiness for special operations and combat rescue personnel. Greg was selected as the Command Senior Enlisted Leader for Special Operations Command Europe (SOCEUR) in 2013. While at SOCEUR, he led special operations forces through multiple contingencies in Ukraine, Turkey, and operations in Syria. In 2015, Greg became the Command Senior Enlisted Leader for NATO Special Operations Headquarters (NSHQ). In this role, he synchronized Allied Special Operations Forces for employment in support of NATO missions across the globe. From 2016 to 2019, Greg served as the Command Chief Master Sergeant, Air Force Special Operations Command. His last assignment was as Command Senior Enlisted Leader for United States Special Operations Command.

Greg completed 14 combat deployments throughout his career, supporting operations in the Balkans, Iraq, Afghanistan, and Africa. He has flown more than 3500 hours in the AC-130H/U/J, HH-60H, and various aircraft, including 1400 combat hours. He has a bachelor's degree in Political Science and has completed all professional military education, the Summit Course, and the Keystone Course at the National Defense University. Greg's awards and decorations include the Air Force Distinguished Service Medal, the Defense

Superior Service Medal, Legion of Merit, Defense Meritorious Service Medal with oak leaf cluster, Meritorious Service Medal with four oak leaf clusters, Air Medal w/Valor with nine oak leaf clusters, Joint Service Commendation Medal, Aerial Achievement Medal with two oak leaf clusters, Air Force Commendation Medal with two oak leaf clusters, Army Commendation Medal, Joint Service Achievement Medal, Air Force Achievement Medal with two oak leaf clusters, Combat Action Medal, Polish Medal with Gold Bar, Lithuanian Armed Forces Medal for Special Operations, and the NATO Medal for Yugoslavia.

Greg and his wife currently reside in Orchard Park, New York and schedule their lives around Buffalo Bills football.

Force Master Chief Jason Avin was born in Queens, New York and raised on Long Island. He graduated from General Douglas Macarthur High School in 1993 and enlisted in the Navy in 1996. He graduated from the United States Navy Senior Enlisted Academy and completed the Command Master Chief / Chief of the Boat Leadership Course.

Upon returning from his second deployment, Corporal Baker was deployed to Kuwait in support of Operation Desert Fox in February of 1998. Upon returning from deployment in July of 1998, Sergeant Baker reported for duty with 3rd Battalion, 5th Marines, Camp Pendleton California.

While at 3rd Battalion, 5th Marines, Sergeant Baker deployed to Idaho in the fall of 2001 in support of TF Wildfire, as a stick leader. In 2002, Sgt Baker was meritoriously promoted to SSgt. In December of 2002, SSgt Baker again deployed to Okinawa with the 31st MEU as a Platoon Sergeant. In September of 2002, Staff Sergeant Baker received orders to Marine Corps Detachment Aberdeen Proving Grounds, Maryland (MCD, APG).

While at MCD APG, Staff Sergeant Baker served as Platoon Sergeant from 2002 until he deployed in 2004 as a Combat Advisor to Afghanistan, in support of Operation Enduring Freedom. Upon his return from deployment, he assumed the role of Detachment Gunnery Sergeant. In August of 2005, SSgt Baker received orders to 1st Battalion, 9th Marines Camp Lejeune, North Carolina.

While at 1st Battalion, 9th Marines, SSgt Baker held the billets of Platoon Sergeant and Platoon Commander. SSgt Baker was selected and promoted to Gunnery Sergeant, and in September of 2006 was reassigned to 6th Marine Regiment, Camp Lejeune, North Carolina.

In December of 2006, Gunnery Sergeant Baker deployed with 6th Marine Regiment to Fallujah, Iraq, in support of Operation Iraqi Freedom. While on deployment he held the billets of Ground Watch Officer and Company Gunnery Sergeant. Upon returning from deployment in January of 2008, Gunnery Sergeant Baker received orders to 2nd Battalion, 9th Marines, Camp Lejeune, North Carolina.

While at 2nd Battalion, 9th Marines, Gunnery Sergeant Baker deployed to Ramadi, Iraq, in support of Operation Iraqi Freedom as Company Gunnery Sergeant. Upon returning from deployment, Gunnery Sergeant Baker again deployed to Khost Province, Afghanistan, as Counter IED team leader assigned to TF Paladin. Upon returning from deployment, Gunnery Sergeant Baker was selected to Master Sergeant, was Frocked and issued orders to Marine Corps Tactics and Operations Group (MCTOG), Twentynine Palms California.

Following his time as a Faculty Advisor at MCTOG, MSgt Baker received orders to the 24th MEU, Camp Lejeune, North Carolina. In June of 2013 while at the 24th MEU, MSgt Baker deployed as the Operations Chief with Special Purpose MAGTF Crisis Response Africa. Upon returning from deployment, MSgt Baker again deployed as Headquarters Commandant/Assistant Operations Chief on the 24th MEU in December of 2014.
