Master Chief Amato is a native of Beacon, New York and enlisted in the United States Navy in July 2001. Following Basic Training at Recruit Training Command, Great Lakes, IL, he attended Basic Enlisted Submarine School and Submarine Machinist's Mate "A" school in Groton, CT.

Upon graduation, he reported for duty onboard Submarines as an Auxiliary Machinist's Mate. He deployed Six times on his first three submarines: USS OKLAHOMA CITY (SSN 723), He also served on the USS SAN FRANCISCO (SSN 711), and USS NORFOLK (SSN 714). Ashore, Master Chief Amato served at Naval Recruiting District New England and SPAWAR Atlantic.



He has his Bachelor's degree in Organizational Leadership from the University of Charleston and holds a Master's Degree from University of Massachusetts Global.

Master Chief Amato served as the Chief of the Boat onboard USS JOHN WARNER (SSN 785), homeported in Norfolk, VA, from July 2018 to May 2021. During his tour, he conducted extensive operations in the Atlantic, deployed to the northern Atlantic, and selected for Command Master Chief. Master Chief Amato's first CMC posting was to Ocean Processing Facility, Whidbey Island. As the CMC for Submarine Squadron ONE Master Chief Amato is the senior enlisted leader for the staff as well as the seven assigned Virginia class submarines.

His decorations include Two Meritorious Service Medal, Navy and Marine Corps Commendation Medal (4 awards), and the Navy and Marine Corps Achievement Medal (8 awards), as well as various unit and campaign awards.

Master Chief Amato is married to Joy Amato of New York, and resides in Pearl Harbor, HI with his three boys, Mason, Landon, and Jordan.

Sergeant Major Ashby assumed his current post as the Command Senior Enlisted Leader for Marine Aircraft Group 26 on November 26, 2024. He enlisted in the United States Marine Corps on June 26, 2000, from Kansas City, Missouri, attended recruit training at Marine Corps Recruit Depot, San Diego, completed Marine Combat Training at Camp Pendleton, California, and completed military occupational training at Marine Corps Communication Electronic School in Twentynine Palms, California, where he earned the Military Occupational Specialty 5942, Aviation Radar Repairer. In October 2005, he earned the Military Occupational Specialty 5948, Aviation Radar Technician.

# United States Navy Biography

## Command Master Chief Petty Officer (Surface Warfare/Aviation Warfare/Fleet Marine Force Warfare) Rafael Barney II

---

Master Chief Petty Officer Barney was born in Queens, New York. He joined the Navy on August 3, 2000 upon graduating from Southridge Senior High School in Miami, Florida. After completion of basic training and Fireman Apprentice "A" School at Great Lakes, IL, he reported to the USS JOHN C. STENNIS (CVN 74) where he was assigned to the Electronics Division of the Engineering Department.

Master Chief Barney went on to attend Religious Program Specialist (RP) "A" school from September to October 2001, graduating at the top of his class and selected as the Honor Graduate. He returned to the STENNIS to work for the Command Religious Ministries Department and deployed shortly after 11 September 2001 in support of Operation ENDURING FREEDOM.

Master Chief then went on to serve with the Marine Corps as he successfully completed Marine Corps Expeditionary Skills Training at Camp Lejeune, NC and was sent to the 1<sup>st</sup> Marine Logistics Group in Camp Pendleton, CA where he became the "Battalion RP" for the 7th Engineer Support Battalion. Master Chief deployed to Iraq in support of Operation IRAQI FREEDOM under the First Regimental Combat Team, First Marine Expeditionary Force assigned to Camp Fallujah, Iraq in 2004.

Upon completion of his tour of duty in Iraq, Master Chief Barney transferred to Naval Air Station Sigonella (Sicily, Italy) and served as the Leading Petty Officer of the Religious Ministries Department and was selected as Sigonella's 2007 Senior Sailor of the Year. Master Chief Barney then reported to the Office of the Chief of Navy Chaplains in the Pentagon in 2008 where he was promoted to Chief Petty Officer in September 2008. Master Chief then went on to become the Religious Program Manager for Commander, Navy Region Europe, Africa, Southwest Asia based out of Naples, Italy where he was promoted to Senior Chief Petty Officer in July of 2013. He followed that overseas tour with one in Jacksonville, Florida where he served as the manager of the religious programs for all naval installations across Navy Region Southeast from December 2014 to February 2018.

Master Chief was promoted to the last paygrade of the enlisted ranks in the summer of 2017. He reported to Navy Personnel Command in 2018 as the lead detailee for the Religious Program Specialist rating. While serving as the PERS-405 DLCPO he was selected to the Command Senior Enlisted Leader program in February of 2020 and reported in October of 2020 as the Command Master Chief (CMDCM) of "America's Lead Destroyer", the USS ARLEIGH BURKE (DDG-51). Master Chief went on to serve as the CMDCM of Naval Support Activity Souda Bay Greece from August of 2023 to 2025 before reporting to be the CMDCM for Naval Supply Systems Command, Fleet Logistics Center Bahrain in August 2025.

Master Chief Barney's awards include the Meritorious Service Medal (three awards), the Navy Commendation Medal (four awards), the Navy Achievement Medal (seven awards), the Military Outstanding Volunteer Service Medal, various unit awards, and campaign and service medals. He has earned a Bachelor of Science degree in Psychology and a Master of Divinity degree from Liberty University in Chaplaincy. He is an honor graduate of the Navy's Senior Enlisted Academy as well as a graduate of the Command Master Chief Course.

In this position Chief Birkle performed and supervised military actions involving security of the electromagnetic spectrum to maintain friendly use, while identifying, attributing, exploiting, and mitigating hostile use.

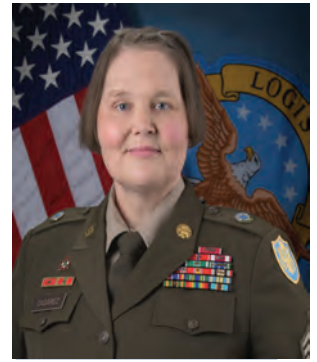

# SENIOR FELLOWS



## Lyons, Stephen “Steve” GEN, USA (Ret)

Steve Lyons is a Senior Fellow for the National Defense University supporting the Pinnacle, Capstone, and Keystone programs. He also serves as Strategic Advisor and Board Director for several organizations.

He retired from the U.S. Army in December 2021 following over 38 years of active service culminating as the 13th commander of U.S. Transportation Command (TRANSCOM). TRANSCOM is one of 11 Presidentially appointed and Senate confirmed combatant commands in the Department of Defense. TRANSCOM operates the multibillion-dollar defense transportation system, routinely deploying and sustaining military forces, providing aerial refueling, medical aerial evacuation, and humanitarian assistance to support US national security goals around the globe. In 2021 he led the mobility operation that enabled the historic evacuation of over 124,000 Afghans and other non-combatants from Kabul international airport.

He began his career in Germany during the Cold War and subsequently held a wide range of assignments to include command of troops at every level, multiple combat deployments, and over eight years of experience in joint (multi-service) assignments. As a battalion commander in 2003, he led more than 1,200 Soldiers as part of the 3d Infantry Division ground assault to liberate Baghdad. He subsequently spent more than 40 months deployed to the U.S. Central command area of responsibility in support of Operation Iraqi Freedom and Operation Enduring Freedom, Afghanistan.

A native of Rensselaer New York, General Lyons graduated from the Rochester Institute of Technology (RIT) and was commissioned a second lieutenant in the US Army in 1983. He holds two master's degrees, one from the Naval Postgraduate School in supply chain management; and the second from the Industrial College of the Armed Forces in national resource strategy. His awards include the defense distinguished service medal, the master parachutist badge, and numerous leadership awards. He has been recognized in the Congressional Record and inducted into the Hall of Fame at the 82d Airborne Division, Naval Postgraduate School, U.S. Army Materiel Command, and U.S. Army Ordnance Corps.



Following his retirement from the military he was appointed by the President of the United States to be the Special Envoy for Ports and Supply Chains holding that position until January 2024. As a key member of the White House Supply Chain Disruption Task Force, he led collaboration among industry, labor, academic, and government stakeholders to address pandemic induced bottlenecks impacting inflation and consumer confidence. During his tenure as Special Envoy he played a central advisory role in resolving railroad, parcel freight, longshore labor contracts, and led a government interagency Unified Coordination Group (UCG) focused on domestic crisis response.

GEN (Ret) Lyons and his wife of 35 years reside in Davidson, North Carolina.



Scott Stalker is a distinguished leader, published author, and professional speaker with over three decades of experience in the Marine Corps. His career spans leadership roles across the Marine Air-Ground Task Force (MAGTF), Space, Cyberspace, Intelligence, and Special Operations, and includes seven combat tours in Somalia and Iraq, as well as a Non-Combatant Evacuation Operation in Tirana, Albania. He deployed with HMM-365, 26th MEU (SOC), 1st Battalion, 7th Marines, and 7th Marine Regiment, and deployed while assigned to all three active-duty Marine Corps Divisions. Scott has deployed onboard the USS Guam, USS Nashville, USS Nassau, and USS Blue Ridge.
